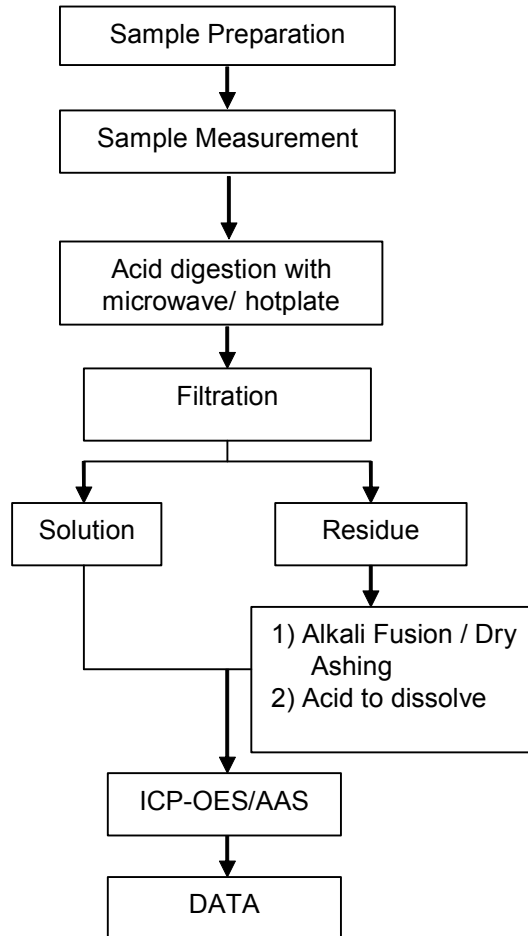

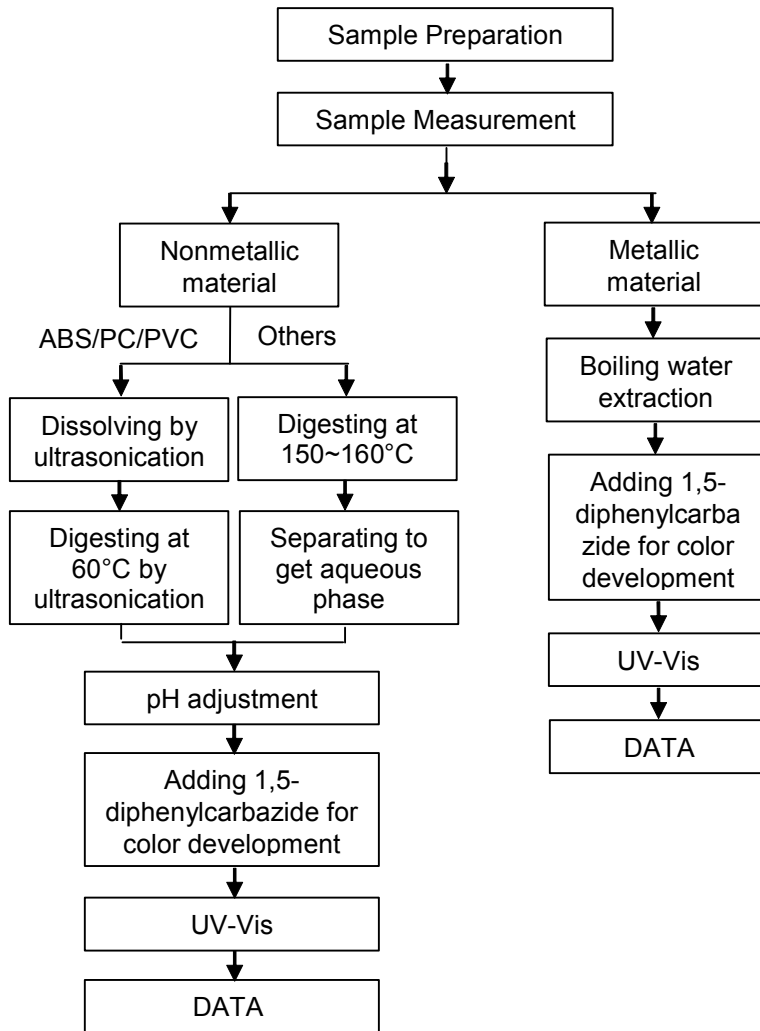

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

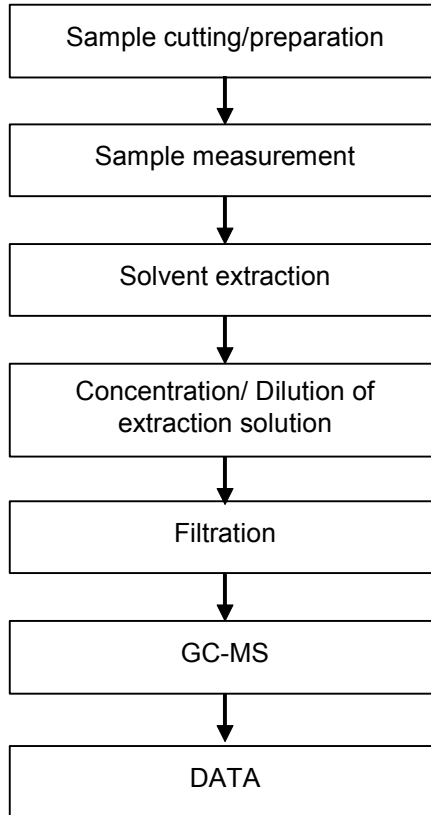

PBBs/PBDEs Testing Flow Chart

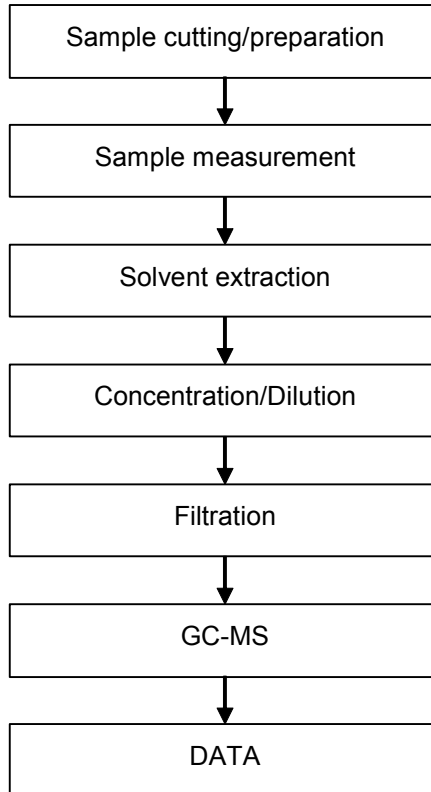

Phthalates Testing Flow Chart

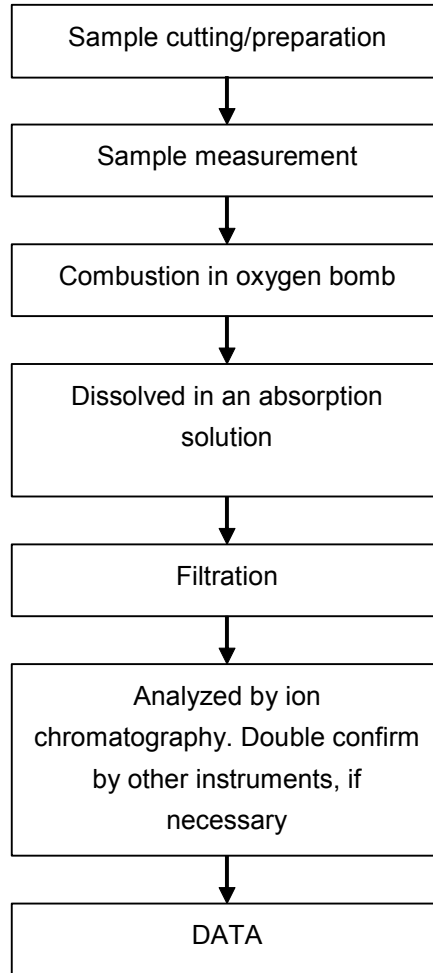

Halogen Testing (oxygen bomb) Flow Chart

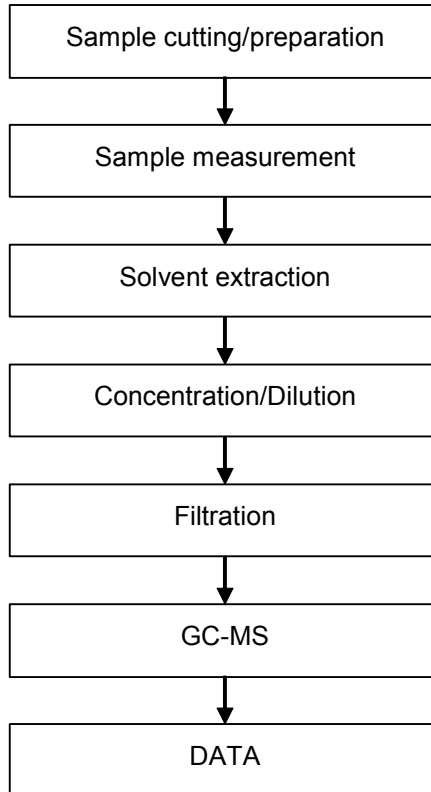

HBCDD Testing Flow Chart

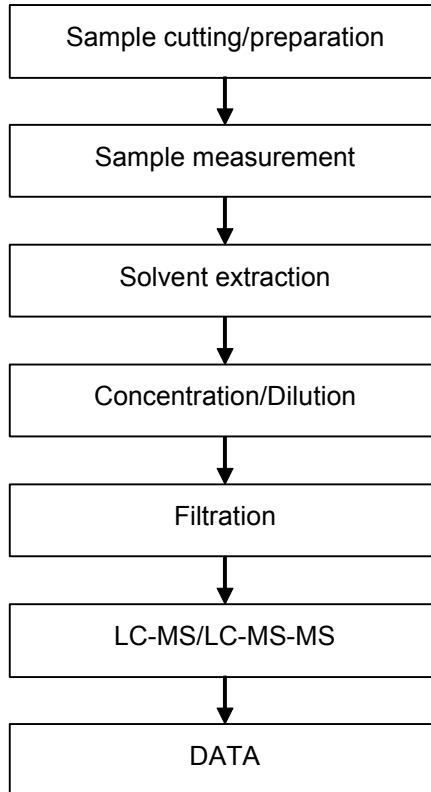

PFASs/ PFOS/PFOA Testing Flow Chart

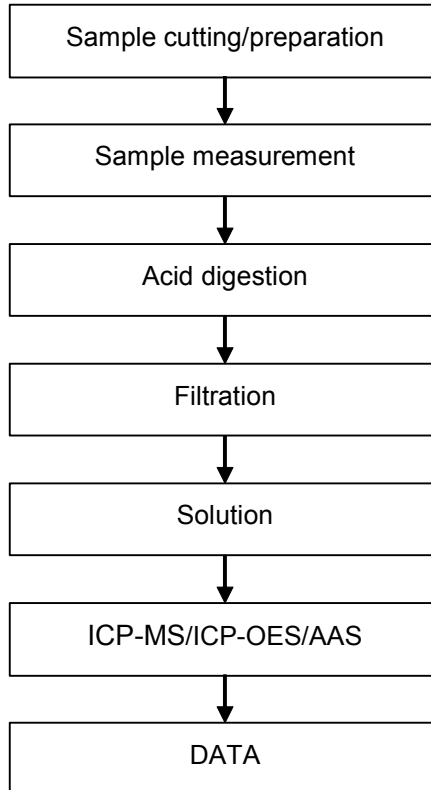

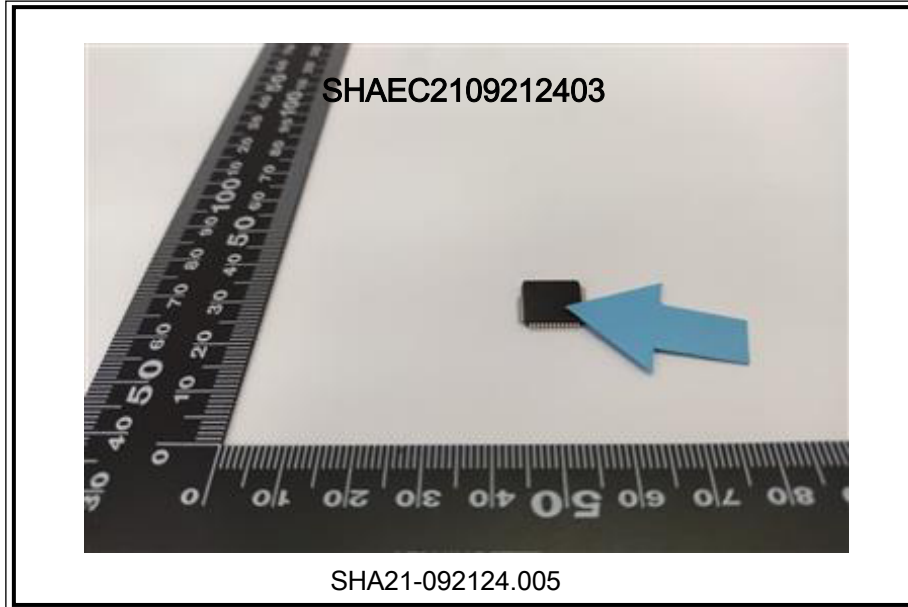
Elements Testing Flow Chart
